Welcome and Introductions

P. Panza welcomed Steering Committee members and meeting attendees.

Approval of Minutes

Proposed Grant Program Components

- P. Panza presented an overview of the proposed HWOTC Trail Project Grant Program components, including grant categories and requirements, grant funding distribution, grant program timeline, grant application review processes, and project evaluation and prioritization criteria.
 - Members discussed specifics of each presented component and requested additional information and clarification on a number of items. BWCF staff, including P. Panza and E. Bush, provided additional information and clarifications.

Implementation Fund

• FHWO staff provided an update on the status of the HWOTC Implementation Fund, noting that the fund is expected to recover to the original amount soon and will be reconfigured for stability, per the Steering Committee's previous direction.

• P. Panza provided activity updates for each HWOTC Working Group:

- 2 of the 5 planned Trail Blazers Challenge events are complete, and the next planning event is the Amaryllis Festival on December 9th.
- Steering Committee members provided a correction to the Ocoee Block Party event start and end time: 4:00 to 7:00pm

Design & Connections

• The trail characteristics survey designed to support the Trailside Design Guidelines has been distributed. P. Panza requested that members continue to distribute the survey through their networks to increase engagement.

Enhance & Restore + Safety

- P. Panza notified members that the "Enhance & Restore" and "Safety" Working Groups are being merged into a singular "Enhance" Working Group beginning January 2024, working under shared objectives originally identified in the Healthy West Orange Trails Initiative Report.
- A trail safety audit along the West Orange Trail is scheduled for November 17th in Winter Garden; an additional trail safety audit along the West Orange Trail in Ocoee is scheduled for December 15th.
 - Another in December 15 in Ocoee, details TBD
- The working group will be reconfiguring the 2022 Trail Safety Survey to widen the area of interest to the entire HWOTC area; the new survey will be distributed in early 2024.

New Business

Other Business

- ACTION: L. Boettcher motioned to transition focus of the Design & Connections Working Group to explore leveraged partnerships and invite new members with appropriate expertise once the Trailside Development Design Guidelines are completed; T. Myers seconded the motion. Discussion ensued.
 - L. Boettcher amended the motion to provide for a transition to a bi-monthly Design & Connections Working Group meeting upon completion of the Trailside Development Design Guidelines and creation of a new Working Group meeting on an opposite bi-monthly schedule focused on maximizing the leveraging opportunities of the HWOTC Trail Project Grant Program; T. Myers seconded the motion. <u>Motion passed unanimously.</u>
- ACTION: L. Boettcher made a motion to enable the Executive Committee to authorize BWCF's continued facilitation of the HWOTC program in 2024; G. Corless seconded. <u>Motion passed unanimously.</u>
